SUBJECT: WestPac Area Restructuring Update

As recently communicated by the Postmaster General and Executive Leadership, phased organizational changes were introduced last fall to update the Postal Service's structure allowing for the implementation of strategy improvements that will ultimately drive organizational success and financial sustainability.
